In compliance with Appendix A, Article 51, of the National Sporting Code:

In accordance with the World Rally Championship Sporting Regulations Article 67.2, testing by teams registered in the World Rally Championship and/or teams supported by a Manufacturer, is strictly prohibited.

The Automobile and Touring Club of Lebanon bans practising on public roads other than as arranged via the CSN.

The testing of rally cars as well as tyres, by all organisers, competitors, teams as well as entrants, local and/or foreign, must be coordinated through the CSN or be carried out on private property.

Test roads will bear the same characteristics of the Lebanese Rally Championship events.

Fees will apply to testing co-ordinated by the CSN.

Unauthorised testing will be reported to the CSN. Failing to observe this rule will be subject to a penalty at the discretion of the ASN disciplinary authorities which may go as far as license withdrawal.

Competitors, teams as well as entrants must complete a special entry form and pay the designated fee before taking part in testing sessions.

I the undersigned hereby declare that I have been acquainted with the abovementioned article and in accordance with the required conditions and in signing this form I agree to the abovementioned charges and stipulations under any reserve.

DECLARATION OF INDEMNITY

My participation in the "testing" of rally cars as well as tyres is at my own risk and I will not hold the Organisers of the 33rd Rally of Lebanon, its Officials, the FIA as well as the ATCL (Automobile and Touring Club of Lebanon) responsible for any accidents, corporate and /or material damages, injuries etc during the testing.

I hereby declare that we, (entrant, crew), as well as the testing car, are insured for personal injuries and for civil liabilities towards third parties. We also declare to have full knowledge of the rules and regulations issued by the FIA and the ATCL covering and governing motor racing in all its aspects. I guarantee to respect all such rules and regulations, without exception.
